3. HAZARDOUS IDENTIFICATION

POTENTIAL HEALTH EFFECTS

Eye Contact: May cause moderate to severe irritation, blurred vision, and burns.

4. FIRST AID MEASURES

Skin Contact: Flush skin with plenty of water and wash with a non-alkaline skin cleaner. Wash contaminated clothes before reuse. Get medical attention if irritation develops.

Precautions To Be Taken In Handling And Storage: Store in a cool, dry, well ventilated area. Keep containers closed. Do not store with incompatible materials. Do not store or consume food, drink, or tobacco where they may become contaminated with this material.

Other Precautions: All labeled precautions must be observed when handling, storing and transporting empty containers due to product residues. Do not reuse containers. Triple rinse before disposal. Dispose of in a licensed facility. Recommended crushing or other means to prevent re-use.
